## **OUR MISSION AND GOALS**

At the Prague Centre for Media Skills (PCMS), our mission is to promote fair, inclusive, and informed societies through high-quality journalism and communication. Our goals are rooted in the fundamental principles of human rights, rule of law, democracy, inclusion, equality, sustainability, and respect for individual rights and aspirations.

In the rapidly evolving technological landscape, the role of artificial intelligence (AI) has become increasingly significant. Al's growing influence on media and communication necessitates a critical examination of its impact on society. Our mission now also includes ensuring that AI advancements contribute positively to journalism and democracy. We are committed to preventing digital divides and ensuring that no one is left behind in the tech era. Media's role in democracy is more crucial than ever, serving as society's watchdog and a promoter of transparency and accountability.

#### Our goals include:

- Promoting journalistic excellence through training, mentoring, study tours, and conferences.
- Encouraging professional dialogue across borders to drive systemic change.
- Collaborating with communication specialists, academics, activists, and stakeholders to utilize media for societal transformation.
- Enhancing digital literacy and helping citizens understand and engage with technology in a meaningful way.

We strive to create a dynamic, transparent, and fair society both in Europe and in countries transitioning to democracy.



#### PCMS PROJECTS AND ACTIVITIES IN 2023

In 2023, PCMS has focused on delivering the final outputs of the Norway Funds-funded project "Promoting Human Rights in the Digital Era," which began in 2022. PCMS has also ensured the future continuation and expansion of the project's main outputs, extending its reach primarily to Norway through the TechWatch project. This continuation has been supported by the Open Society Fund Prague, the Committee of Good Will – Olga Havel Foundation, and the Czech Scouting Institute within the Active Citizens Fund program, financed by the EEA and Norway Grants.



## • International Project: Promoting Human Rights in the Digital Era

In 2023, we continued our work on the <u>"Promoting Human Rights in the Digital Era"</u> project. This initiative, funded by Norway Funds (No. LP-HRMGSA-017) and led by the Czech NGO <u>luridicum Remedium</u>, aims to raise awareness and professional standards in journalism regarding the impact of modern technologies on human rights. The project emphasizes the importance of digital literacy and human rights awareness of future and current media professionals and the ethical implications of Al and other technologies.

Within the project, which concluded in January 2024, PCMS carried out several significant activities and achieved numerous outputs:

**Development of a University Course at the Faculty of Social Sciences of the Charles University:** We developed a <u>comprehensive university course</u> for media students and future journalists, focusing on digital and human rights. These programs aimed to equip journalists and media students with the knowledge and skills necessary to navigate the digital landscape

responsibly. PCMS was responsible for three lectures in the <u>13-lecture cycle</u>. Our <u>opening lecture</u> on March 22, 2023, featured accessibility specialist <u>Mariana Chytilova</u> as a guest speaker. On March 29, 2023, the <u>second lecture</u> covered the impact of modern technologies on people with special needs. The <u>third lecture</u>, on April 26, 2023, focused on the impact of digitalization and new technologies on human rights. Following the completion of the undergraduate course, a set of <u>study texts</u>, including PCMS contributions, <u>was published</u> on July 7, 2023.

INSPO Conference Presentation: On November 25, 2023, we presented the 'Promoting Human Rights in the Digital Era' project at the INSPO Conference during Digital Week. The presentation highlighted gaps in journalists' awareness about the impact of technology on people with disabilities and their specific needs in accessing it. INSPO is the major ICT conference in the Czech Republic for people with special needs, having been at the forefront of introducing novel technologies and exploring new accessibility options in the country for over two decades.

**Launch of Online Course:** We launched a <u>live 10-video online course</u> on November 29, 2023. The course, available with Czech and English subtitles, <u>covers essential topics</u> such as cybersecurity, privacy, accessibility, and algorithmization. PCMS produced <u>two videos</u> for the course targeted at media professionals to increase understanding of digitalization's impact on human rights, mainly from the perspective of <u>people with special needs</u>, <u>media, and accessibility.</u>



**Guidelines for Journalists:** On October 18, 2023, we published <u>guidelines in Czech</u> for journalists to enhance their understanding of technology and digitalization, aiming to reduce discrimination and human rights abuses. The concise and practical Guidebook was also <u>published in English</u> in December.

**Conference on Media and Human Rights:** On December 1, 2023, we hosted the final <u>project conference</u> titled "Media and Human Rights in the Digital Age" in Prague. The event focused on addressing major digital challenges tied to ongoing digitization, with a special emphasis on understanding the media's reflection of these changes and their impact on human rights. ## • TechWatch Project

Continuing our commitment to expanding the outputs of the previous project, particularly in Norway through our project partners EFN, we initiated the TechWatch project in November 2023. TechWatch aims to monitor and analyze the impact of emerging technologies on media, communication and human rights. Scheduled to continue into 2024, this project focuses on providing insights and recommendations for integrating new technologies while upholding human rights standards and democratic values.

The #TechWatch project was supported by the Open Society Fund Prague from the Active Citizens Fund. The programme promotes citizens' active participation in the public life and decision making and builds capacities of civil society organizations. The Active Citizens Fund is financed from the EEA and Norway Grants.



#### **OTHER ACTIVITIES**

PCMS began the year with its first interview in Russian for Radio Svoboda on **February** 7, 2023. The interview, titled <a href="color: blue;" color: "" (Monopoly on Information: War and Freedom of Opinions in Russia), featured PCMS's Adriana Dergam discussing critical issues surrounding digitalization, resilience to disinformation, and human rights.

During **spring** 2023, PCMS collaborated with communication expert Lucie Bihellerová and the <u>Czech Environmental Information Agency (CENIA)</u> to develop content for their e-learning platform aimed at combating disinformation. Launched in April, this initiative focuses on providing reliable information and resources to help environmental data managers identify and counteract disinformation. The e-learning platform offers a comprehensive set of tools and educational materials designed to enhance public awareness and media literacy, ensuring that users are better equipped to navigate the complexities of information and disinformation in the digital age. On **March** 21, 2023, PCMS participated as a <u>jury member for the prestigious Czech Event Association Awards</u>. This event, hosted by the Czech Event Association, celebrates excellence in the event industry by recognizing outstanding achievements in event management, creativity, and execution. As a member of the jury, PCMS contributed its expertise in evaluating the quality, impact, and innovation of various events.

In **April 2023**, PCMS participated in a <u>course organized by the Czech Ministry of Defense</u>. The course aimed to equip journalists with the essential skills needed to work safely in crisis or other extreme situations. This initiative is crucial in ensuring that media professionals are prepared for the challenges they might face in volatile environments, thus enhancing the quality and safety of their reporting.

Moving into **June 2023**, PCMS was actively involved in the international "Media and Ukraine" conference. This event, organized by Czech Public Radio (Český rozhlas) as part of its 100th anniversary celebrations, focused on the critical role of media in conflict zones and the importance of accurate reporting in shaping public perception and policy.

In **July 2023**, PCMS collaborated with the <u>Democracy Protection Network</u> initiative. Together, we assessed the key trends, risks, and opportunities for democracy in the past year. This partnership aimed to identify strategic approaches to safeguarding democratic values amidst rising global challenges.

Later, in **September 2023**, PCMS participated in a significant conference organized by <u>ASNEP</u> and <u>DeafFriendly</u>, which addressed accessibility and the needs of people with hearing impairments. This event highlighted the importance of inclusive communication and the role of media in ensuring the all sections of society receive adequate coverage and are properly informed.



**October** saw PCMS joining the <u>27th Forum 2000 Conference in Prague</u>, themed "For a Democratic World Order." During this conference, we engaged in discussions on media topics, focusing on the media's role in supporting and promoting democratic principles globally.

The nonprofit organization Prague Centre for Media Skills (PCMS) was founded in 2016 by an international group of Prague-based media professionals with experience working in former Soviet Union countries. This expert nonprofit organization was created to address the needs of local journalists and newsrooms, particularly those working in areas of active or frozen conflict.

#### II. General Accounting Principles

#### II.1. Long-term Assets

The accounting unit does not record any tangible or intangible assets.

#### II.2. Securities and Shares

The accounting unit does not own any securities.

#### II.3. Inventory

The accounting unit does not hold any inventory.

#### II.4. Receivables

Receivables are valued at their nominal value at the time of their inception. The organization typically does not create provisions.

The accounting unit does not have any overdue receivables.

#### II.5. Liabilities

The accounting unit does not have any overdue liabilities.

As of the balance sheet date, the following liabilities are recorded:

- Employee liabilities: CZK 24,862

- Social and health insurance institutions: CZK 9,145

- Tax office: CZK 3,825

- Liability to the chairman, who covered a delayed grant repayment from his own funds:

CZK 205,000

#### II.6. Accruals

The organization accounts for expenses for future periods. This includes necessary accounting of unused indirect costs according to grant rules, amounting to CZK 27,786.73.

The prepayment for the company's registered office, amounting to CZK 11,979, is recorded as an expense for future periods.

#### **II.7. Public Collections**

The accounting unit does not organize any public collections.

#### II.8. Donations Received

In the reporting year, the organization received donations for operations amounting to CZK 34,000, which were accounted for in accordance with accounting regulations in fund 911100, and were not used in the year of receipt.

#### II.9. Grants Received

The accounting unit is currently a recipient of a grant from the EEA/Norway Financial Mechanism 2014-2021. The provider of the financial resources for project implementation and the Program Operator is the Ministry of Finance of the Czech Republic.

The project, titled "Support for Human Rights in the Digital Age: Raising Awareness and Standards of Journalistic Work on the Impact of Modern Technologies on Human Rights," is implemented by a consortium of four organizations, with luridicum Remedium, z.s. as the applicant.

The total grant value is CZK 5,300,000, with a duration from 01.01.2022 to 31.01.2024. PCMS's allocated portion for its activities is CZK 1,065,870. As of 31.12.2023, the organization has received only the first instalment of CZK 632,059.

#### II.10. Own Capital

The organization does not have its own capital.

Up until 2023, the organization did not generate any revenue that would necessitate filing a tax return.

The organization holds funds in bank accounts made available by the chairman.

#### II.11. Income Tax

The organization is a public benefit taxpayer in accordance with §17a of Act No. 586/1992 Coll., on Income Taxes, as amended (hereinafter referred to as ZDP).

The organization applies the exemption of donations according to §19b paragraph 2 b) ZDP whenever possible.
